Welcome to the first iSIMPATHY newsletter. iSIMPATHY is an EU funded project running until March 2023 across the three jurisdictions of Northern Ireland, Scotland and the border areas of the Republic of Ireland. The project ensures the best and most sustainable outcomes with medication use in patients taking multiple medicines. Some of the fuller 69 case finding indicators may pick up a rare patient with one long term illness. iSIMPATHY helps enable patients to lead healthy and active lives by supporting both them and clinicians to define and achieve realistic goals of drug treatment through medicine reviews. In this update we share reflections on the key milestones the project has reached, provide details of upcoming learning events and training, and how you can help share the message about the project.

#### Major milestone reached

"The review considered me as a whole person, not just my medical conditions" (Seamus, 62 years). Over 2,500 medicine reviews have now been completed. All pharmacists were in post by February 2021, and we asked for their reflections on the last 6 months, and what they are hoping to achieve. Many of the challenges have been overcome,

with highly positive feedback from wider multi-disciplinary teams and patients: "My review was not rushed and hugely beneficial to my care" (Steven, 45 years) and "The project deliverables drive you to drive change, and that makes a difference

to patients" (Project

Pharmacist). Looking ahead we aim to understand the benefits of the project in a different setting, and share learning to support delivery and training.

### **Training and learning opportunities**

We have several learning opportunities running this autumn.

- Accredited online training for doctors and healthcare professionals is launching soon. The course covers delivering medicines reviews and integrating them within health and care processes, shared learning and opportunities for improving optimisation of medicines.
